Additional Details:

Description of the Planned Network Change(s):

The DMS switch, located at CO, Union Star, MO 64494, will be decommissioned, powered down, and removed from Windstream's network as a result of network modernization and consolidation. All traffic will need to be routed to the UNSTMOXAPSO Meta Switch. Windstream Union Star A-Block of 816-593 is being moved to UNSTMOXAPSO.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the UNSTMOXAPS0 Meta Switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Union Star, MO DMS switch will be required to reposition the codes to the UNSTMOXAPS0 Meta Switch.



All ASRs for the UNSTMOXAPS0 Meta Switch must be received no later than June 1, 2022, in order to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Union Star MO DMS switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Union Star, MO DMS switch (on or after June 4, 2022). This will serve to guide interconnect re-routes of Windstream traffic for native codes currently served by the Union Star, MO DMS switch to reflect the UNSTMOXAPS0 Meta Switch as the new home switch. All ASRs for the UNSTMOXAPS0 Meta Switch must carry the project code of UNSTMOXAPS0.
