Description of the Planned Network Change(s):

The DMS10 switch, located at 410 RTE, Luthersburg, PA, will be decommissioned, powered down, and removed from Windstream's network as a result of network modernization and consolidation. All traffic will need to be routed to the LUBGPAXLPS0 Meta Switch. Windstream A-Block of 814-583 is being moved to LUBGPAXLPS0.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the LUBGPAXLPS0 Meta Switch or have existing trunk groups to that switch augmented. Carriers that are code

holders for access connectivity in the Luthersburg, PA DMS10 Switch will be required to reposition the codes to the LUBGPAXLPS0 Meta Switch.

All ASRs for the LUBGPAXLPS0 Meta Switch must be received no later than April 27, 2022 in order to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Luthersburg, PA DMS10 Switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Luthersburg, PA DMS10 Switch (on or after May 1, 2022). This will serve to guide interconnect re-routes of Windstream traffic for native codes currently served by the Luthersburg, PA DMS10 Switch to reflect the LUBGPAXLPS0 Meta Switch as the new home switch. All ASRs for the LUBGPAXLPS0 Meta Switch must carry the project code of LUBGPAXLPS0.
