Description of the Planned Network Change(s):

The DMS10 switch, located at 4558 Butterfield Trl, Florence, MO 65329, will be decommissioned, powered down, and removed from Windstream's network as a result of network modernization and consolidation. All traffic will need to be routed to the FLRNM0XAPS0 Meta Switch located at 4558 Butterfield Trl, Florence, MO 65329. In addition, Windstream Florence A-Block of 660-368 is also being moved to FLRNM0XAPS0.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the FLRNM0XAPS0 Meta Switch or have existing trunk groups to that switch augmented. Carriers that are code

holders for access connectivity in the Florence, MO DMS10 switch will be required to reposition the codes to the FLRNMoxAPS0 Meta Switch.

All ASRs for the FLRNMoxAPS0 Meta Switch must be received no later than November 30, 2022 in order to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Florence, MO DMS10 switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Florence, MO DMS10 switch (on or after December 1, 2022). This will serve to guide interconnect re-routes of Windstream traffic for native code currently served by the Florence, MO DMS10 switch to reflect the FLRNMoxAPS0 Meta Switch as the new home switch. All ASRs for the FLRNMoxAPS0 Meta Switch must carry the project code of FLRNMoxAPS0.
