### Document Production General Fee schedule – Civil

Admin Fee (ALL Civil cases will be charged this fee whether there is information to release. This will cover the initial investigation and setting up the case)	\$50.00
Subscriber Information (Basic)	\$10.00/target
Subscriber Information (IP)	\$15.00/target or subscriber
IP Address Log per username	\$17.00 for the first 3 months, then \$17.00 per month for sequential months
Bill Images per invoice – Call Detail Records kept during normal course of business: billing records (411, collect, toll, etc.)	\$10.00 for the first 3 months, then \$10.00 per month for sequential months
Call Detail Records Inbound or Outbound/AMA– Information NOT included on a bill: local incoming or outgoing	\$25.00 per month per target

#### \*Voluminous and Burdensome Request

Windstream bills law enforcement and other government agencies, and civil litigants for “voluminous and burdensome” requests for customer records or other information served on Windstream and it’s subsidiaries in the form of court orders, warrants, subpoenas, or associated customer consent. Criteria considered when determining whether a request may be voluminous and burdensome include, but are not limited to, the following:

- A legal request for 15 numbers or more requesting subscriber/billing/credit/features, or 30 numbers or more requesting subscriber information.
- The response to a legal request amount to 100 pages or more of print or electronic copy; or
- The legal request requires one (1) or more hours to process in a civil case.
- Voluminous and burdensome charges may apply to a single legal request or multiple legal requests from the same agency associated with the same case or cause number, as determined by Windstream Services, LLC.

*All civil costs billed are due and payable prior to the delivery of documents to the requesting party.*

### Electronic Surveillance Fee Schedule

Cost for the implementation of a Court Ordered - Pen Register/Trap and Trace &/or Wiretap/FISA requiring deployment of an intercept device are as follows:

NSL	No charge
CALEA Services: Full Content or Pen Register/Trap & Trace - New Installation Fee	\$1,250.00 per target for either Business or Residential customer
CALEA Services: Full Content or Pen Register/Trap & Trace – Monthly Maintenance	\$750.00 for monthly maintenance per target or \$2,250 every 3 months per target
Per Court Order Requests for Information	Subject to the General Fee Schedule only if the surveillance order was served on another carrier
Call Detail records (AMA) or email headers/logs released in response to an ongoing Surveillance Court order: Per week for one time per week	\$150.00 per week for one time per week delivery of incoming & outgoing call detail records or email headers/logs for the duration of the original order & any extension of the original order.
Call Detail records (AMA) or email headers/logs released in response to an ongoing Court order: More frequent delivery	Additional \$50.00 per delivery
Simple Modify (DID CHANGE) – Billed immediately	\$15.00 per target
Troubleshooting (per hour – charged in 15-minute increments) – Billed immediately	\$60.00

- Requesting Law Enforcement Agencies must complete a [CALEA Electronic Surveillance Certification Form](#) providing detailed billing information and point of contact. The CALEA Certification form can be found on Windstream’s Law Enforcement Support Center Resource page.
- Billing will occur upfront for the install and monthly maintenance for the first 3 months of surveillance unless otherwise noted in the docket. If interception extends past the 3 months, then billing will occur at each 3 month interval.
